



## **Ganga Dwar Hostel Resident - Agreement**

**This Resident Agreement ("Agreement") is made between Ganga Dwar Hostel ("Hostel") and the undersigned resident ("Resident"). By signing this Agreement, the Resident agrees to abide by the Hostel's Code of Conduct and all policies and regulations set forth herein.**

### **1. General Behavior**

- 1.1. The Resident agrees to treat all fellow residents, guests, and staff with respect and consideration. Discrimination, harassment, bullying, or any form of abusive behavior will not be tolerated.
- 1.2. The Resident shall adhere to the noise level policy, keeping noise to a minimum and using headphones when listening to music or watching videos, especially during designated quiet hours from 9:00 PM to 7:00 AM.
- 1.3. The Resident acknowledges that the possession, use, or distribution of illegal drugs is strictly prohibited, and alcohol consumption is only allowed in designated areas and must be done responsibly.

### **2. Cleanliness and Hygiene**

- 2.1. The Resident agrees to maintain cleanliness in personal and shared spaces, properly dispose of trash, and clean up after oneself in the kitchen and bathrooms.
- 2.2. The Resident will store all food in designated areas and dispose of expired food promptly.
- 2.3. The Resident commits to maintaining good personal hygiene for the comfort of all and to using showers responsibly, avoiding the creation of water puddles or leaving personal items in common bathrooms.

### **3. Safety and Security**

- 3.1. The Resident agrees not to tamper with or disable any security systems, including CCTV cameras, locks, and other equipment. Any security concerns or suspicious activities must be reported to hostel staff immediately.

### **4. Visitors and Guests**

- 4.1. The Resident understands that visitors are allowed in common areas only during visiting hours from 11:00 AM to 5:00 PM and that overnight stays for visitors are not permitted.
- 4.2. The Resident agrees to be responsible for the behavior of their guests and ensuring they follow all hostel policies. Any damage or disturbance caused by guests will be the responsibility of the hosting resident.

### **5. Property and Maintenance**

- 5.1. The Resident agrees to take good care of all hostel property and facilities and to report any damage or malfunction immediately to management.
- 5.2. The Resident acknowledges that items posing a safety risk, such as candles, incense, hot plates, or any open flame devices, are not allowed in rooms.
- 5.3. The Resident will not make permanent alterations to their room, such as painting walls or installing fixtures, without prior approval from management.

### **6. Internet and Technology Use**



6.1. The Resident agrees to use the hostel's Wi-Fi for reasonable use only and understands that activities requiring excessive bandwidth or that are illegal are prohibited.

6.2. The Resident is responsible for securing their devices and personal information. The hostel is not responsible for any loss or damage resulting from cyber activities.

### **7. Emergency Procedures**

7.1. The Resident agrees to familiarize themselves with fire exits, alarms, and extinguishers and to follow all emergency procedures in case of an emergency.

7.2. The Resident will report any health emergencies to hostel staff immediately and is advised to have basic medical supplies and inform management of any chronic health conditions or allergies.

### **8. Violations and Penalties**

8.1. The Resident acknowledges that minor infractions, such as noise violations or cleanliness issues, will result in a warning. Repeated violations may result in a fine or other disciplinary actions.

8.2. The Resident understands that major infractions, such as theft, violence, or drug use, will result in immediate eviction from the hostel without refund and potential legal action.

8.3. The Resident agrees that all violations will be reviewed by hostel management and that the management's decisions are final.

### **9. Amendments and Updates**

9.1. The Resident acknowledges that the Hostel reserves the right to amend the Code of Conduct at any time and agrees to comply with all updated policies.
